



The Co-op terms & conditions of entry

BACK TO UNI 2017 SEMESTER REWARD VOUCHER

1. Information on how to enter form part of these Conditions of Entry.
2. The Promoter is the University Co-operative Bookshop Ltd, Level 1, 15 Foster Street, Surry Hills 2010, (02) 93259600 ABN 70 009 937 160.
3. Entry into the **BACK TO UNI 2017 SEMESTER REWARD VOUCHER** Promotion is deemed to be an acceptance of these Conditions of Entry.
4. **BACK TO UNI 2017 SEMESTER 1 REWARD VOUCHER** Promotion commences 13th February 2017 12:01am AEST and closes at 11:59pm AEST on the 28th March 2017 (Promotion Period).
5. Entry is only open to customers living in Australia. Employees (and their immediate families) of the Promoter, or agencies or companies associated with the conduct of this Promotion, are ineligible to enter.
6. To receive a reward voucher in the **BACK TO UNI 2017 SEMESTER 1 REWARD VOUCHER** Promotion the Co-op member or online registered customer must follow these steps:
 - i. Receive an email inviting the customer to take part in the promotion
 - ii. Produce a valid Membership number at time of purchase or purchase using a valid Membership via the Co-op online at www.coop.com.au **OR**
 - iii. Be a registered online customer of the Co-op with a valid email address **AND**
 - iv. Purchase over the nominated spend threshold detailed in the invitation email collectively during the promotional period
